## Board of Energy Regulatory Office

Taking into account:

1. The provisions of the Law No. 2004/8 “On Energy”;
2. The provisions of the Law No.2004/9 “On the Energy Regulator”;
3. The provisions of the Temporary Instruction I\_03\_2006 “On the Principles of Calculation of Tariffs and Prices in the District Heating Sector in Kosovo for the Heating Season 2006/2007”; and
4. The fact that Public Municipal Utility (PMU) Zvecan didn’t submit to Energy Regulatory Office (ERO) the application for heating tariffs for heating season 2006/2007.

Has decided to:

1. Approve the heat tariff rates for PMU Zvecan for the whole of the six months of the Heating Season 2006/2007 as presented in the Table “A” and “B”; the approved tariff rates are decided to remain the same as in the heating season 2005/2006 due to the non-submission of tariff application and consequently the absence of relevant information contained therein.
2. The approved tariff rates shall be published by PMU Zvecan, in one national and one local daily newspaper circulated in Kosovo, within five (5) working days after the Energy Regulatory Office’s announcement and publication of the decision on the official ERO’s website.
3. Energy Regulatory Office (ERO) will make use of the rights given by the law, to verify actual data and audit accounts and invoices of PMU Zvecan as well as to perform reconciliation of current tariff (heating season 2006/2007) with new projected one (heating season 2007/2008).
4. During the heating season 2006/2007, PMU Zvecan may present to the Energy Regulatory Office proposal for justified changes in its approved tariff, according to Temporary Instruction I\_03\_2006 “On the Principles of Calculation of Tariffs and Prices in the District Heating Sector in Kosovo for the Heating Season 2006/2007”.
5. PMU Zvecan has the right to appeal to ERO by submitting a fully substantiated report, within ten (10) calendar days after the announcement and publication of the decision on the official ERO’s website.
6. In reference to the paragraph 1 of this decision, ERO Board will consider the appropriate penalty to be applied as per Article 57 of the Law on Energy Regulator and Article 5.4 of Temporary Instruction I\_03\_2006, for failure of PMU Zvecan to submit required information for district heating price review 2006/2007.
