1. The provisions of the Law No. 2004/8 “On Energy”;
2. The provisions of the Law No.2004/9 “On the Energy Regulator”;
3. The provisions of the Temporary Instruction I_05_2007 “On the Principles of Calculation of Tariffs and Prices in the District Heating Sector in Kosovo for the Heating Season 2007/2008”;
4. Tariff application for heat tariffs for the season 2007/2008 submitted by District Heating (DH) Gjakova JSC to Energy Regulatory Office (ERO) on 10th September, 2007;
5. Comments to the tariff application provided by ERO on 25th of September 2007;
6. Revised tariff application of DH Gjakova JSC submitted on 28th of September, 2007;
7. Decision D_71_2007 on Determination of Allowed Revenues for DH Gjakova JSC for Heating Season 2007/2008, issued by ERO on 1st of November 2007, accompanied by ANNEX “REGULATORY REPORT – Determination of Allowed Revenues for DH Gjakova JSC, for Heating Season 2007/2008”.
8. Tariff proposal submitted by DH Gjakova JSC to ERO on 5th of November, 2007;

Has decided to:

1. Approve the tariff rates for DH “Gjakova” JSC for the whole of the six months of the Heating Season 2007/2008 as presented in the Table “A” and “B” and detailed calculation presented in ANNEX to this decision “REGULATORY REPORT – Tariff Setting for DH “Gjakova” JSC for Heating Season 2007/2008”.

Tariff of heat delivered (variable component)	€ 45.89 / MWh

2. The approved tariff rates, shall be published by DH “Gjakova” JSC, in one national and one local daily newspapers circulated in Kosovo, within five (5) working days after the Energy Regulatory Office’s announcement and publication of the decision on the official ERO’s website.
3. This decision comes into effect from the date of issue and is applicable from the date of its publication in website of ERO.
4. This decision is issued in Albanian, Serbian and English language. In case of dispute between the different languages the Albanian version shall prevail.
5. DH “GJAKOVA” JSC has the right to appeal to ERO by submitting a fully substantiated report, within ten (10) calendar days after the announcement and publication of the decision on the official ERO’s website.
