Considering:

1. Article 15 and 34/a of the Law on Energy Regulator, and
2. Article 4 and 6 of the Rule on Licensing of Energy Activities in Kosovo

The Board of Energy Regulatory Office, in the session held on 3 of May 2007, has issued the following:

## **DECISION**

**To REFUSE the application of MC INVEST CONSULTING AD for Supply/Trade License with Electricity.**

1. The Energy Regulatory Office (ERO) on 09.10.2006 has received by regular mail the application for Supply /Trade license with electricity sent by MC INVEST CONSULTING AD company.
2. During the first assessment of the application and the evidences sent, it has been attested the lack of the following proofs:
  - The Certificate that the Applicant is a regular taxpayer – issued by the tax agency – point 2 of the application;
  - The Certificate that the Applicant is not a subject of any procedure for insolvency or liquidation – issued by the competent institution – point 3 of the application;
  - Revenues Statement of the Applicant for the last (3) three years. If the annual financial statement of the Applicant has been subject to an independent financial auditing, then he has to present the auditing report separate from the financial statement–point 4 of the application;
  - The copy of the registry of shareholding participation with percentage or equity of any shareholder or partner of the Applicant, including copies of provisions of the association, decisions of the Court or the book of shareholders - point 7 of the application;
  - Attestation of the application fee payment – point 11 of the application;
  - Information on the ownership of material sources, including data on constructed networks, possession of the software for the performance of the activities – point 1 of the specific conditions in the application.
3. During direct telephone contacts with representatives of the respective company, as well as by the e-mail sent on 24.10.2006, were requested all missing evidences.

4. On 27.03.2007 we have once more requested to send the required evidences within a term of (7) seven days.
5. Since the party was allowed the due legal term and so far none of the requested evidences were sent, ERO has decided to refuse the application of MC INVEST CONSULTING AD for Supply /Trade license with electricity
6. This decision is issued in three languages: Albanian, Serbian and English. In cases of discrepancies between languages, the Albanian version shall prevail.
7. Within 14 days from the day of approval or from the day of publication of this decision in the official website of ERO, the discontent party may lodge a complaint against this Decision, in the court of respective jurisdiction.
8. This Decision shall enter into effect on the date of its issuance or on the date of publication in the official website of ERO.
