Taking into account the:

1. Provisions of the Sections 15 and 26 of the Law on the Energy Regulator,
2. KEK SH.A. Request for derogation in implementing the Section 16.4 and 22.1 of the Rule on Switch-offs and Re-Switching of the Customers in the Electrical Energy Sector in Kosova dated May 21st, 2007.

The Board of the Energy Regulatory Office in its session held in May 31st 2007 has issued this:

## **DECISION**

1. KEK SH.A. **is allowed** to perform commercial switch-off of the customers including the after working hours period, holidays and feasts, that are related to usage of the Electrical Energy pursuant to Sec.5 of the Rule on Switch-off and Re-switching of the Customers in the Electrical Energy Sector in Kosova under the following conditions:

- a) Exempt of implementing the Sec. 22.1 of Rule on Switch-off and Re-Switching of the Customers in the Energy Sector in Kosova is allowed only for six (6) months since the approval day of this decision,
  - b) KEK SH.A. should organize the invoicing and payment service during the whole time of the commercial switching-offs following the Sec. 5 of Rule on Switch-off and Re-Switching of the Customers in the Energy Sector in Kosova;
  - c) KEK SH.A should perform the commercial switch-offs with particular caution following the paragraph 1, and only in cases when there is no doubt that the electrical energy has been consumed in conformity with the Sec. 5 of the Rule in question.
2. **KEK SH.A. is allowed** the exempt (exclusion) of implementing the Sec. 16.4 which determines the cases of electrical energy consumption pursuant to Sec. 5 of the Rule in Question and will not apply that minimal time-frame of ten (10) days since the switch-off notification day until the switching off itself. This exclusion will be allowed for six (6) months since the issuance day of this decision.

3. All the provisions of the Rule on Switch-off and Re-Switching of the Customers in the Energy Sector in Kosova will remain effective.
4. Not later than three (3) months since the approval day of this decision, KEK SH.A is **obliged** to propose for consideration and approval by ERO Board, the policies on switching-off and re-switching of the electrical energy customers pursuant to Sec.5 of this Rule.
5. This Decision is issued in three languages: Albanian, Serbian and English. Should any discrepancy between these languages emerge, the Albanian version will prevail.
6. The unsatisfied claimant may file a complaint against this Decision before the respective Court and Jurisdiction within 14 days since the approval and publication date of the decision in the official ERO web-site..
7. This Decision enters into power in the date of issue or in the date published in the official ERO web-site
