### DECISION

- I. "DH Termokos" **is allowed** derogation in implementation of provisions of the following sections in:
  - License for District Heating Generation
  - License for Distribution of District Heating; and
  - License for District Heating Public Supplying, pursuant to annex of this decision.
1. All other provisions of the DH Termokos' licenses remain in power.
2. This decision is issued in three languages: Albanian, Serbian and English and will be published in the official ERO web-page.
3. Dissatisfied party may appeal against this decision before the court of respective jurisdiction, within 14 days since the date of allowing or the date of publication of this decision in the official ERO web-page.
4. This decision enters into power in the date of its issuance or its publication in the official ERO web-page.
