



**The Board of Energy Regulatory Office following:**

1. Its legal mandate as provided in Articles 45 to 48 of the Law No. 2004/9 "On Energy Regulator" amended by Law No. 03/L-080;
2. Provisions of the Article 7 of the Rule "On Authorization Procedure for the Construction of New Generation Capacities, Gas Networks, Electric-energy Lines and Direct Pipelines."
3. Annex A, Item D2 in the Schedule of Fees approved by ERO on 17.01.2006,

**In its session held on 1 April 2009 adopted this:**

**DECISION**

1. **The List of Fees** for reviewing applications for authorization of the construction of new generation capacities **is approved.**

**Justification**

1. Pursuant to Article 23 of the Law on Energy Regulator, ERO has the mandate to collect fees for reviewing applications which should be paid when applications are submitted. Among the applications to be reviewed is also the application for the construction of new generation capacities, gas networks, direct electric-energy lines and direct pipelines.
2. Article 7.1 of the Rule of Authorization Procedure also determines that all applicants for authorization shall pay a fee to ERO for their administrative expenses at the amount specified in the ERO's Decision.
3. The amount of fee was determined by referring to Annex A of the Schedule of Fees as well as experiences and practices of regional regulators, and appears as follows:

<i>Installed capacity of the New Generator</i>	<i>Price/Euro</i>
<i>New generator of capacity to 5 MW</i>	<i>1,500.00</i>
<i>New generator of capacity over 5 MW to 10 MW</i>	<i>3,000.00</i>
<i>New generator of capacity over 10 MW to 50 MW</i>	<i>5,000.00</i>
<i>New generator of capacity over 50 MW to 100 MW</i>	<i>7,000.00</i>
<i>New generator of capacity over 100 MW to 200 MW</i>	<i>20,000.00</i>



4. If the new generator will have an installed capacity of 200 MW, then the fee for reviewing the application shall be determined by a decision of the Board based on the generator's actual construction cost
5. This decision shall be issued in Albanian language and translated into Serbian and English. In the event of any discrepancy between different versions, the version in Albanian shall prevail.
6. This decision enters into force on the date of its approval by the ERO Board and shall be published in the ERO's official webpage.

**Legal remedy:** Against this decision unsatisfied parties may file complaints before the court in the respective jurisdiction within (14) days since the date of its approval or publication in the ERO's official website.
