## Board of the Energy Regulatory Office

### Taking into account:

1. Article 15, 26, and 31 of the Law on Energy Regulator amended by Law No. 03/L-080;
2. Article 37 of the Rule on Licensing Energy Activities in Kosova,
3. Provisions of Article 37.2 of the Law on Trade Societies, and
4. Request dated 26.12.2008 for an extension of the electric energy supply/trade license and performance of electric energy trade activity, submitted by “Rudnap Group AD” Enterprise, BLVD Mihaila Pupina 6/21, 11070 New Belgrade, Serbia.

### In its meeting held on 27 May 2009 adopted this:

## DECISION

- I. The validity of the electric energy supply/trade license of the “Rudnap Group AD” Enterprise, No. ZRRE\_Li\_23/07 issued on 23.05.2007 **IS EXTENDED** for **the next two (2) years**.
- II. **The extension** of the license shall be valid for the period 23.05.2009, the expiry date of the initial period of the license validity, through 23.05.2011.

## Justification

1. Energy Regulatory Office (ERO) on 26.12.2008 received a request from “Rudnap Group AD” Enterprise for the extension of electric energy supply/trade license No. ZRRE\_Li\_23/07, dated 23.05.2007 which expired on 23/05/ 2009.
2. ERO evaluated the request of the “Rudnap Group AD” Enterprise and in conformity with the legal provisions mentioned in the introduction of this decision decided as stated in the disposition of this decision.
3. In deciding about the said request, ERO took into account the provisions of the Article 37.2 of the Law on Trade Societies, which stipulate that foreign traders are not required to be

registered as trade societies in Kosova if the electricity is to be delivered to a wholesale buyer in Kosova.

4. This extended license allows the licensee to perform only electric energy **trade** activity in Kosova.
5. If the licensee wants to carry out also electric energy supply activities stipulated by Sec. 4 of the license, then it should meet other obligations set out in the Law on Trade Societies and in the applicable legislation in Kosova.
6. This decision is issued in Albanian language and shall be translated into Serbian and English. In the event of any discrepancy between various versions, the Albanian version shall prevail.
7. This decision is effective on the day of its approval by the ERO Board and shall be published in the official ERO web-site.

**Legal remedy:** Against this decision, unsatisfied parties may initiate a lawsuit before the competent court in Prishtina within (14) days since the day of receiving or publishing the decision in the web-site, whichever occurs first.
