**Based on:**

- Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.15, Article 25, Article 26, paragraph 1, subparagraph 1.2 and Article 43, paragraph 1 of the Law on Energy Regulator (No. 05/L-084);
- Article 25 of the Rule No. 11/2017 on the Authorization Procedure for Construction of New Capacities based on Renewable Energy Sources;
- Articles 18, 19 and 20 of the Rule No. 10/2017 on the Support Scheme for RES Generators, and
- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, in the facility cadastral area No.00486-20, with an installed capacity of 100 kW, in Municipality of Ferizaj, dated on 23.06.2020, prot. No. 258/20, of the applicant "GNTC GROUP" JSC, having its address at: "Cen Durguti" Street, Municipality of Ferizaj, Republic of Kosovo,

in the session held on 27 August 2020 issued the following:

**DECISION**  
**FOR CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION**

- I. **APPROVAL**- of the request of the applicant "GNTC GROUP" JSC, for construction of generation capacities for self-consumption from solar/photovoltaic panels, in the facility in the cadastral area No. 00486-20, in line with the Consent no. 04-016/01-0048957/20, dated on 08.07.2020, issued by Directorate for Urbanization and Environment, with an installed capacity of **100 kW**, to be placed over the facility, in Municipality of Ferizaj.
- II. The applicant "GNTC GROUP" JSC, with the registered code of the electric meter DFE-9021234, is hereby **OBLIGED** to submit e request at KEDS JSC for technical admission of the energetic facility, following the construction of new generation capacities for self-consumption.



- III. ERO shall consider the project finalized from the date of technical admission, in line with the Energy Approval, issued by KEDS JSC.
- IV. The applicant "GNTC GROUP" JSC shall bond an Agreement for self-generation with the supplier with whom it has an electricity supply contract, following the confirmation of the technical admission from KEDS JSC, in line with Article 18, paragraphs 1 and 2 of the Rule No. 10/2017 on the Support Scheme.

### **Reasoning**

- ERO, on 23.06.2020, received from the applicant "GNTC GROUP" JSC the application for obtaining the decision for construction of new generation capacities for self-consumption from solar/photovoltaic panels, in the facility in the cadastral area No. 00486-20, in line with the Consent no. 04-016/01-0048957/20, dated on 08.07.2020, issued by Directorate for Urbanization and Environment, with an installed capacity of 100 kW, to be placed over the facility in Municipality of Ferizaj.
  - The applicant, along with the application has also attached KEDS evidence on annual consumption of electricity, evaluation on annual production on kW/h of the installed equipment, energy approval No. 4402, dated on 19.06.2020, issued by KEDS JSC, and Consent No. 04-016/01-0048957/20, dated on 08.07.2020, issued by Directorate of Urbanization and Environment of Municipality of Ferizaj.
  - ERO Board, following the analysis of the request of the applicant "GNTC GROUP" JSC, and attached evidence, for construction of new generation capacities for self-consumption from solar/photovoltaic panels, in the facility in the cadastral area No. 00486-20 with an installed capacity of **100 kW**, in Municipality of Ferizaj, evaluated them and considered that all relevant evidence on issuance of decision for construction of generation capacities for self-consumption have been fulfilled, therefore based on legal provisions mentioned in the introductory section of this Decision, has decided as in the enacting clause to this Decision.
- V. The Decision is issued and published in official languages of the Republic of Kosovo.
- VI. The Decision shall enter into force on the date of approval by the Board, and will be published on the electronic website of ERO.



**Legal advice:** The dissatisfied parties may address the Competent Court to object this Decision within thirty (30) days from the date of the receipt of this Decision or its publication on ERO's website, whichever occurs last.
