**I Approval of the documents:**

- Harmonized allocation rules for long-term transmission rights
- Rules for explicit Daily Capacity Allocation on Bidding Zone borders serviced by South East Europe Coordinated Auction Office (SEE CAO) Version 2.0
- Specific Annex for the Bidding Zone borders serviced by SEE CAO to the Harmonised Allocation Rules for long-term transmission rights

**R e a s o n i n g**

KOSTT is a shareholder in the South East Europe Coordinated Auction Office (SEE CAO), therefore it is obliged to require the amendments in the relevant legislation through the requests for approval at ERO. Within this, Energy Regulatory Office, on 17.10.2022 received the request of KOSTT for approval of the amendments of the rules: *Harmonized allocation rules for long-term transmission rights, Rules for explicit Daily Capacity Allocation on Bidding Zone borders serviced by South East Europe Coordinated Auction Office (SEE CAO) Version 2.0, and Specific Annex for the Bidding Zone borders serviced by SEE CAO to the*

*Harmonised Allocation Rules for long-term transmission rights;*

Initially, these rules were approved by ERO on 12 March 2014 and then their amendment was approved on 03 October 2016 and the same were also amended on 12 November 2020.

This amendment was initially approved on 3 June 2022 by the Board of Directors of CEE CAO, and these rules have undergone a public consultation organized by SEE CAO, as well as KOSTT, where each stakeholder was entitled to provide relevant comments or suggestions.

ERO, following the review of the documents, as well as the current circumstances for carrying out the auction activity for allocation of capacities, approved the documents according to the request of KOSTT, no. 2094, dated on 17.10.2022 on Update of the Auction Rules for Allocation of Capacities in the South East Europe Coordinated Auction Office.

The entry into force of these documents repeals their previous version approved by ERO Board, on 12.11.2020.

**II.** The decision is issued and published on the official languages of the Republic of Kosovo.

**III.** The decision shall enter into force on the date of approval by the Board and will be published on the electronic website of ERO.

**Legal advice:** The party dissatisfied with this decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of the Decision or the date of its publication on ERO's website, whichever occurs last.
