The Board of Energy Regulatory Office,

Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 15, Article 26, paragraph 1, sub-paragraph 1.2, Article 28, paragraph 2, sub-paragraph 2.11, Article 30 and Article 32 of the Law on Energy Regulator (Law no. 05/L-084);
- Provisions of Article 32 of the Law on Electricity (Law no. 05/L-085);
- Provisions of Article 3, paragraph 1, sub-paragraph 1.11, Article 4, Article 6, Article 7, Article 8 and Article 15 of the Rule no. 07/2017 on Licensing of Energy Activities in Kosovo;
- Application with attached documents, dated on **31.03.2023** on licensing of electricity supply (trade) activity, submitted by the company **Eurosol&Energy LTD LLC**, having its address at: **St. Vicianum**, no.23, 10000, Pristina, Republic of Kosovo.

the session held on 05 May 2023 issued the following:

DECISION

- I. ISSUANCE of LICENSE for electricity wholesale supply (trade) to the company Eurosol&Energy LTD LLC (Eurosol&Energy, trade name) with license number ZRRE/Li_89/23, for the period of five (5) years and shall be valid from 15.05.2023 until 14.05.2028.
- II. The company is **obliged** to submit to the Regulator any document issued by different institutions to **Eurosol&Energy LTD LLC** which can have an impact on the validity and validity period of the issued license as well as any document which can differ from the ones submitted during the course of application for obtaining the license.

Reasoning

- Energy Regulatory Office (the Regulator), on 31.03.2023 received from representatives of the company Eurosol&Energy LTD LLC the application with relevant evidence on licensing of electricity wholesale supply (trade) activity in Kosovo.
- The Regulator evaluated that the enterprise in question has acted in line with the instructions
 of the Regulator and the requirements foreseen in the application for licensing of electricity
 wholesale supply (trade) activity in Kosovo and other applicable legislation.
- According to Article 6 of the Rule on Licensing of Energy Activities in Kosovo, the company Eurosol&Energy LTD LLC, on 05.05.2023 notified through newspaper (portals due to the lack of newspapers) the stakeholders that it has submitted to the Regulator the Application for licensing of electricity wholesale supply (trade) activity and that the application is in the final





phase for obtaining the license. The stakeholders were entitled to contradict the application if they could prove any irregularities thereof within eight (8) calendar days from the day when the notice was published on the newspaper (portal). The Regulator did not receive any contradiction submitted by the parties regarding this application.

- The Regulator, in line with Article 7 of the Rule on Licensing of Activities in Energy Sector in Kosovo issues a formal decision for each license application within sixty (60) calendar days, from the date when the application is deemed complete.
- The license issued in line with this decision shall continue to be valid for the period according to point I of the enacting clause to this decision, with the possibility of extension, if the licensee applies for license extension **no later than six (6) months** prior to expiry of the license, in line with Article 32 of the Law on Energy Regulator and other legislation in force.

The Regulator, following the evaluation of the application and other evidence attached to the application of the company **Eurosol&Energy LTD LLC** and based on the legal provisions mentioned in the introductory section of this decision, has decided as in the enacting clause to this decision.

- III. The decision is issued in official languages of the Republic of Kosovo.
- **IV.** The decision enters into force on the date of approval by the Board of the Regulator and will be published on the official website of the Regulator.

Legal advice: The party dissatisfied with this decision may initiate an administrative dispute at the competent court within thirty (30) days from the date of receipt of the decision or the date of its publication on ERO's website, whichever occurs last.
