- Articles 18, 19 and 20 of Rule No. 10/2017 on Support Scheme for RES Generators;
- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility, cadastral area no. 01341-1 CA Obiliq, with an installed capacity of **70 kW**, in Municipality of Obiliq, received on 11.01.2023, from the natural person applicant "Fatmir Mjeku" B.I.", having its address at: "Obiliq", Municipality of Obiliq, Republic of Kosovo.

in the session held on 27 January 2023, issued the following:

## DECISION

### ON CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. **APPROVAL** of the request of the applicant "Fatmir Mjeku" B.I., for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, to be placed on the roof of the facility, cadastral area no. 01341-1 CA Obiliq, with an installed capacity of **70 kW**, in Municipality of Obiliq.
- II. The applicant "Fatmir Mjeku" B.I., with electric meter registration number DPR - 2002697, is **OBLIGED** to submit a request at KEDS JSC for technical admission of energy facility, following the construction of new generation capacities for self-consumption.
- III. ERO shall consider the project as finalized from the date of technical admission, based on the Electro-Energetic Consent, issued by KEDS JSC.
- IV. The applicant "Fatmir Mjeku" B.I." shall bond a self-generation agreement with the supplier with whom it has bonded an electricity supply contract, following the confirmation of technical admission by KEDS JSC., in accordance with Article 18, paragraphs 1 and 2 of Rule No. 10/2017 on Support Scheme.



## Reasoning

- ERO, on 11.01.2023, received from the applicant “Fatmir Mjeku” B.I.” the application on obtaining the decision for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, to be placed on the roof of the facility, cadastral area no. 01341-1 CA Obiliq, with an installed capacity of **70 kW**, in the Municipality of Obiliq.
- The applicant, along with the application, also attached evidence from KEDS on annual energy consumption, evaluation of annual production in kW/h of the installed equipment, Electro-Energetic Consent no. 13726, dated on 30.10.2022, issued by KEDS JSC., and the Consent No. VI-82, dated on 18.02.2022, issued from the Directorate of Public Services and Emergency of the Municipality of Obiliq.
- ERO Board, following the analysis of the request of the applicant “Fatmir Mjeku” B.I.”, and attached evidence, for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility , cadastral area no. 01341-1 CA Obiliq, with an installed capacity of **70 kW**, in Municipality of Obiliq, evaluated them and considered that all relevant evidence on issuance of the decision for construction of new generation capacities for self-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory part of this Decision, decided as in the enacting clause of this Decision.

**V.** The Decision is issued and published in official languages of the Republic of Kosovo

**VI.** This Decision shall enter into force on the date of approval by the Board and shall be published on ERO’s official website.

**Legal advice:** The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO’s website, whichever occurs last.
