- Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.15, Article 25, Article 26, paragraph 1, sub-paragraph 1.2 and Article 43, paragraph 1 of Law on Energy Regulator (No. 05/L-084);
- Article 25 of Rule No. 11/2017 on Authorization Procedure for Construction of New Generation Capacities from Renewable Energy Sources;
- Articles 18, 19 and 20 of Rule No. 10/2017 on Support Scheme for RES Generators;
- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.02211-6 CA Tankosiq, with an installed capacity of **100 kW**, in Municipality of Ferizaj, received on 26.01.2023, from the legal person applicant "SEFA METAL", having its address at: St. "Trankosiq", Municipality of Ferizaj, Republic of Kosovo,

in the session held on 23 March 2023 issued the following:

DECISION

ON CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. APPROVAL of the request of the applicant "SEFA METAL", for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.02211-6 CA Tankosiq, with an installed capacity of 100 kW, in Municipality of Ferizaj.
- **II.** The applicant "SEFA METAL", with electric meter registration number DFE 9013265, **is OBLIGED** to submit a request at KEDS JSC for technical admission of energy facility, following the construction of new generation capacities for self-consumption.
- **III.** ERO shall consider the project as finalized from the date of technical admission, based on the Electro-Energetic Consent, issued by KEDS JSC.
- IV. The applicant "SEFA METAL" shall bond a self-generation agreement with the supplier with whom it has bonded an electricity supply contract, following the confirmation of technical admission by KEDS JSC., in accordance with Article 18, paragraphs 1 and 2 of Rule No. 10/2017 on Support Scheme.





Reasoning

- ERO, on 26.01.2023, received from the applicant "SEFA METAL" the application on obtaining the decision for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.02211-6 CA Tankosiq, with an installed capacity of **100 kW**, in the Municipality of Ferizaj.
- The applicant, along with the application, also attached evidence from KEDS on annual energy consumption, evaluation of annual production in kW/h of the installed equipment, Electro-Energetic Consent no. 13757 dated on 30.12.2022, issued by KEDS JSC., and the Decision No. 013, dated on 19.01.2023, issued from the Directorate of Urbanization and Environment of the Municipality of Ferizaj.
- ERO Board, following the analysis of the request of the applicant "SEFA METAL", and attached evidence, for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.02211-6 CA Tankosiq, with an installed capacity of <u>100 kW</u>, in Municipality of Ferizaj, evaluated them and considered that all relevant evidence on issuance of the decision for construction of new generation capacities for self-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory part of this decision, decided as in the enacting clause of this decision.
- V. The Decision is issued and published in official languages of the Republic of Kosovo
- **VI.** This Decision shall enter into force on the date of approval by the Board and shall be published on ERO's official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
