- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 15, Article 16, paragraphs 1 and 2 of the Law on Energy Regulator no. 05/L-084;
- Provisions of Article 8, paragraphs 1 and 6 of the Law on Energy no. 05/L-081;
- Provisions of the Rule and Methodology on Preparation of Energy Balances no.03/2020 (issued in June 2020); and
- Request submitted on 09 November 2022 submitted from the Public Enterprise "Termokos" JSC, having its address at" 28 November, Ulpianë, 10000, Pristina, Republic of Kosovo, on approval of the document" Thermal Energy Annual Balance 2023",

in the session held on 23 March 2023 issued the following:

## DECISION

- I. APPROVAL of the "Thermal Energy Annual Balance 2023" of the Public Enterprise "Termokos" JSC.
- **II.** Following the receipt of this decision, the license is **obliged** to publish the document "Thermal Energy Annual Balance 2023" on its electronic website.

# REASONING

- 1. The Public Enterprise 'Termokos" JSC (in the following text "Termokos") as a holder of the license for operation of thermal energy distribution system, based on the legal provisions of the applicable legislation, has prepared the document "Thermal Energy Annual Balance 2023". In line with the legal and regulatory procedures, the first draft of this document was submitted on 09 November 2022 for review at ERO and the Ministry of Economy. Following the review and the comments on this draft from these two institutions, on 27 January 2023, the revised draft was submitted, in line with the comments. This final draft was published for public consultation from 14 28 February 2023, however no comments, remarks or suggestions were received; therefore, this Draft-Balance was considered finalized to be presented to ERO board for review.
- 2. Following the review of the draft-document "Thermal Energy Annual Balance 2023", submitted by PE Termokos and amendment and supplement in line with the comments provided by ME and ERO, the Board of ERO, based on the legal provisions mentioned in the introductory section of this decision, has decided as in the enacting clause to this decision.





- 3. Taking into account the impact of different parameters of the balance in the determination of tariffs, the Regulator is entitled to adjust the data of the Thermal Energy Balance during tariff review.
- 4. Based on the provisions of Article 42, paragraph 2.3 of the Law on Energy Regulator, ERO monitors the implementation of the Thermal Energy Annual Balance in order to verify the realization of the data and information presented in this Balance and can undertake specific actions for promotion and improvement of short-term and long-term safety of electricity supply.
- V. The decision is issued in official languages of the Republic of Kosovo.
- **VI.** The decision shall enter into force on the date of approval by the Board of the Regulator and will be published on the electronic website of the Regulator.

**Legal advice:** The party dissatisfied with this decision may initiate an administrative dispute at the competent court, within thirty (30) days following the receipt of this decision or its publication on ERO's website, whichever occurs last.
