### The Board of Energy Regulatory Office,

#### Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.5, Article 25, Article 26, paragraph 1, sub-paragraph 1.2 of the Law on Energy Regulator (Law no. 05/L-084);
- Provisions of Article 16, paragraph 1.12 and paragraph 1.13 of the Law on Electricity (Law no. 05/L-085);
- Provisions of Article 12 of the Transmission System Operator License, and
- Request of KOSTT JSC, dated on 07.12.2022 on review and approval of the Transmission Five (5) Year Development Plan 2023-2027,

in the session held on 23 March 2023 issued the following:

## DECISION

- I. APPROVAL Transmission Five-Year (5) Development Plan for the period 2023-2027 of KOSTT JSC.
- **II.** The Transmission System and Market Operator (KOSTT) JSC is **OBLIGED** to implement the projects planned, according to this document, for the safe functioning of transmission system.

## Reasoning

- Energy Regulatory Office (ERO), on 07.12.2022, received the request for review and approval of the Transmission Five-Year (5) Development Plan for the period 2023-2027 of KOSTT JSC.
- ERO analysed the documents and concluded that the same is in harmony with the Transmission Ten-Year (10) Development Plan, spatial planning documentation, Distribution System Operator Development Plan and other legal requirements.
- o ERO, following the evaluation of the Development Plan, opened the public discussion to receive





comments, suggestions and assessments on this document from the licensees and the stakeholders.

- Following the completion of the public consultation and the frequent meetings between ERO, KOSTT and KEDS regarding the harmonization of plans, KOSTT JSC, on 02.03.2023 submitted to ERO for review and approval the Transmission Five-Year (5) Development Plan 2023-2027.
- ERO Board, following the evaluation and analysis of Transmission Five-Year (5) Development Plan 2023-2027 concluded that the legal requirements have been fulfilled and evaluated that the projects included in the document are justifiable and necessary for the safe functioning of the transmission system, therefore decided as in the enacting clause of this decision.
- III. The decision is issued and published in official languages of the Republic of Kosovo.
- IV. The decision shall enter into force on the date of approval by the Board of Energy Regulatory Office and will be published on the official website of ERO.

**Legal advice:** The party dissatisfied with this decision may initiate an administrative dispute at the competent court, within thirty (30) days following the receipt of this decision or its publication on ERO's website, whichever occurs last.
