The Board of Energy Regulatory Office,

Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.5, Article 25, Article 26, paragraph 1, sub-paragraph 1.2 of the Law on Energy Regulator (Law no. 05/L-084);
- Provisions of Article 28, paragraph 1.26 of the Law on Electricity (Law no. 05/L-085);
- Provisions of Article 10 of the Law on Energy (Law no.05/L-081);
- Provisions of Article 10 of the Distribution System Operator License,
- Request of DSO, dated on 21.10.2022 on review and approval of the Distribution Ten-Year (10) Development Plan 2023-2032,

in the session held on 23 March 2023 issued the following:

DECISION

- I. APPROVAL of Distribution Ten-Year (10) Development Plan for the period 2023-2032 of DSO.
- **II.** The Distribution System Operator KEDS JSC is **OBLIGED** to implement the planned projects according to this plan for the safe functioning of the Distribution System.

Reasoning

- Energy Regulatory Office (ERO), on 21.10.2022 received the request for review and approval of the Ten-Year (10) Development Plan of Distribution System Operator for the period 2023-2032 of DSO
- ERO analysed the document and carried out the evaluation of projects to be included in the Ten-Year (10) Development Plan of DSO 2023-2032.
- ERO, during the evaluation, applied a priority listing of projects and programmes based on the prioritization factors agreed between DSO and ERO.
- ERO, following the evaluation of Development Plan, published the same public discussion to receive comments, suggestions and evaluations from the licensees and the stakeholders.





- ERO, during the evaluation period, held joint consultative meetings with DSO, where explanations and responses were provided in relation to the raised issues.
- Following the completion of public consultation and frequent meetings with KEDS, as well as the inclusion of ERO comments, DSO, on 20.03.2023 submitted the final document for approval at ERO.
- ERO Board, following the evaluation and analysis of the Distribution Ten-Year (10) Development Plan 2023-2032 concluded that the legal requirements have been fulfilled and evaluated that the projects included in the document are reasonable and necessary for the safe functioning of the distribution system, therefore decided as in the enacting clause to this decision.
- III. The decision is issued and published in the official languages of the Republic of Kosovo.
- **IV.** The decision shall enter into force on the date of approval by the Board of Energy Regulatory Office and will be published on the official website of ERO.

Legal advice: The party dissatisfied with this decision may initiate an administrative dispute at the competent court, within thirty (30) days following the receipt of this decision or its publication on ERO's website, whichever occurs last.
