- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility in cadastral area no. 02571-61 CA Pristina, with an installed capacity of 8 kW, in Municipality of Pristina, dated on 24.03.2023 of the natural person applicant "Sabit Ademi", having its address at St. "1 Tetori", Municipality of Pristina, Republic of Kosovo.

in the session held on 05 May 2023 issued the following:

DECISION

FOR CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. APPROVAL- of the request of the natural person applicant "Sabit Ademi", for construction of generation capacities for self-consumption from solar/photovoltaic panels, on the roof of the facility in the cadastral parcel no. 02571-61 CA Pristina, with an installed capacity of 8 kW, Municipality of Pristina.
- II. The natural person applicant "Sabit Ademi", with registered code of the electric meter DPR- 26849 is hereby **OBLIGED** to submit e request at KEDS JSC for technical admission of the energetic facility, following the construction of new generation capacities for self-consumption.
- **III.** ERO shall consider the project finalized from the date of technical admission, in line with the Energy Approval, issued by KEDS JSC.
- **IV.** The natural person applicant "Sabit Ademi" shall bond an Agreement for self-generation with the supplier with whom it has an electricity supply contract, following the confirmation of the technical





admission from KEDS JSC, in line with Article 18, paragraphs 1 and 2 of the Rule No. 10/2017 on the Support Scheme.

Reasoning

- ERO, on 24.03.2023, received from the natural person applicant "Sabit Ademi" LLC the application for obtaining the decision for construction of new generation capacities for self-consumption from solar/photovoltaic panels, on the roof of the facility in the cadastral area no. 02571-61 CA Pristina, with an installed capacity of 8 kW, in Municipality of Pristina.
- The applicant, along with the application has also attached KEDS evidence on annual consumption of electricity, evaluation on annual production on kW/h of the installed equipment, Electro-Energetic Consent no. 745, dated on 27.01.2023, issued by KEDS JSC, and the Decision 05 no. 350/02-229440/22, dated on 10.03.2023, issued by Directorate for Urbanization and Environmental Protection of the Municipality of Pristina.
- ERO Board, following the analysis of the request of the natural person applicant "Sabit Ademi" and attached evidence, for construction of new generation capacities for self-consumption from solar/photovoltaic panels, on the roof of the facility in the cadastral parcel no. 02571-61 CA Pristina, with an installed capacity of 8 kW, in Municipality of Pristina, evaluated them and considered that all relevant evidence on issuance of decision for construction of generation capacities for self-consumption have been fulfilled, therefore based on legal provisions mentioned in the introductory section of this Decision, has decided as in the enacting clause to this Decision.
- **V.** The Decision is issued and published in official languages of the Republic of Kosovo.
- **VI.** The Decision shall enter into force on the date of approval by the Board, and will be published on the electronic website of ERO.

Legal advice: The dissatisfied parties may address the Competent Court to object this Decision within thirty (30) days from the date of the receipt of this Decision or its publication on ERO's website, whichever occurs last.
