Based on:

- Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.15, Article 25, Article 26, paragraph 1, subparagraph 1.2 and Article 43, paragraph 1 of the Law on Energy Regulator (no. 05/L-084);
- Article 25 of the Rule no. 11/2017 on the Authorization Procedure for Construction of New Capacities based on Renewable Energy Sources;
- Articles 18, 19 and 20 of the Rule no. 10/2017 on the Support Scheme for RES Generators, and
- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility in cadastral area no. 00261-0 CA Davidovc, with an installed capacity of **7 kW**, in Municipality of Shtime, dated on 06.04.2023 of the natural person applicant "Halim Baftiu", having its address at "Davidovc", Municipality of Shtime, Republic of Kosovo.

in the session held on 05 May 2023 issued the following:

## DECISION

### FOR CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. **APPROVAL**- of the request of the natural person applicant "Halim Baftiu", for construction of generation capacities for self-consumption from solar/photovoltaic panels, on the roof of the facility in the cadastral parcel no. 00261-0 CA Davidovc, with an installed capacity of **7 kW**, Municipality of Shtime.
- II. The natural person applicant "Halim Baftiu", with registered code of the electric meter DFE-9027997 is hereby **OBLIGED** to submit a request at KEDS JSC for technical admission of the energetic facility, following the construction of new generation capacities for self-consumption.
- III. ERO shall consider the project finalized from the date of technical admission, in line with the Energy Approval, issued by KEDS JSC.
- IV. The natural person applicant "Halim Baftiu" shall bond an Agreement for self-generation with the supplier with whom it has an electricity supply contract, following the confirmation of the technical



admission from KEDS JSC, in line with Article 18, paragraphs 1 and 2 of the Rule No. 10/2017 on the Support Scheme.

### **Reasoning**

- ERO, on 06.04.2023, received from the natural person applicant “Halim Baftiu” LLC the application for obtaining the decision for construction of new generation capacities for self-consumption from solar/photovoltaic panels, on the roof of the facility in the cadastral area no. 00261-0 CA Davidovc, with an installed capacity of **7 kW**, in Municipality of Shtime.
  - The applicant, along with the application has also attached KEDS evidence on annual consumption of electricity, evaluation on annual production on kW/h of the installed equipment, Electro-Energetic Consent no. 2505, dated on 27.03.2023, issued by KEDS JSC, and the Consent 06/75, dated on 20.03.2023, issued by Directorate for Urban Planning, Cadastre and Geodesy of the Municipality of Shtime.
  - ERO Board, following the analysis of the request of the natural person applicant “Halim Baftiu” and attached evidence, for construction of new generation capacities for self-consumption from solar/photovoltaic panels, on the roof of the facility in the cadastral parcel no. 00261-0 CA Davidovc, with an installed capacity of **7 kW**, in Municipality of Shtime, evaluated them and considered that all relevant evidence on issuance of decision for construction of generation capacities for self-consumption have been fulfilled, therefore based on legal provisions mentioned in the introductory section of this Decision, has decided as in the enacting clause to this Decision.
- V.** The Decision is issued and published in official languages of the Republic of Kosovo.
- VI.** The Decision shall enter into force on the date of approval by the Board, and will be published on the electronic website of ERO.

**Legal advice:** The dissatisfied parties may address the Competent Court to object this Decision within thirty (30) days from the date of the receipt of this Decision or its publication on ERO’s website, whichever occurs last.
