- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.2302-38 CA Shtime, with an installed capacity of 50 kW, in Municipality of Shtime, received on 18.04.2023, from the legal person applicant "BESIMI COMMERCE" LLC, having its address at: St. "Idriz Seferi", Municipality of Shtime, Republic of Kosovo,

in the session held on 05 May 2023 issued the following:

DECISION

ON CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. APPROVAL of the request of the applicant "BESIMI COMMERCE" LLC, for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.2302-38 CA Shtime, with an installed capacity of 50 kW, in Municipality of Shtime.
- II. The applicant "BESIMI COMMERCE" LLC, with electric meter registration number DFE 9072167, is OBLIGED to submit a request at KEDS JSC for technical admission of energy facility, following the construction of new generation capacities for self-consumption.
- **III.** ERO shall consider the project as finalized from the date of technical admission, based on the Electro-Energetic Consent, issued by KEDS JSC.
- **IV.** The applicant "BESIMI COMMERCE" LLC shall bond a self-generation agreement with the supplier with whom it has bonded an electricity supply contract, following the confirmation of technical admission by KEDS JSC., in accordance with Article 18, paragraphs 1 and 2 of Rule No. 10/2017 on Support Scheme.





Reasoning

- ERO, on 18.04.2023, received from the applicant "BESIMI COMMERCE" LLC the application on obtaining the decision for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.2302-38 CA Shtime, with an installed capacity of 50 kW, in the Municipality of Shtime.
- The applicant, along with the application, also attached evidence from KEDS on annual energy consumption, evaluation of annual production in kW/h of the installed equipment, Electro-Energetic Consent no. 13728 dated on 30.12.2022, issued by KEDS JSC., and the Consent 06/141, dated on 07.07.2023, issued from the Directorate for Urban Planning, Cadastre and Geodesy of the Municipality of Shtime.
- ERO Board, following the analysis of the request of the applicant "BESIMI COMMERCE" LLC, and attached evidence, for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.2302-38 CA Shtime, with an installed capacity of 50 kW, in Municipality of Shtime, evaluated them and considered that all relevant evidence on issuance of the decision for construction of new generation capacities for self-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory part of this decision, decided as in the enacting clause of this decision.
- V. The Decision is issued and published in official languages of the Republic of Kosovo
- **VI.** This Decision shall enter into force on the date of approval by the Board and shall be published on ERO's official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
