- Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.15, Article 25, Article 26, paragraph 1, sub-paragraph 1.2 and Article 43, paragraph 1 of Law on Energy Regulator (No. 05/L-084);
- Article 25 of Rule No. 11/2017 on Authorization Procedure for Construction of New Generation Capacities from Renewable Energy Sources;
- Articles 18, 19 and 20 of Rule No. 10/2017 on Support Scheme for RES Generators;
- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.3599-0,3601-0 and 03901-0-5-0 CA Srecke, with an installed capacity of **95 kW**, in Municipality of Prizren, received on 18.04.2023, from the legal person applicant "SHARRI" LLC, having its address at: St. "Sredsa", Municipality of Prizren, Republic of Kosovo,

in the session held on 05 May 2023 issued the following:

DECISION

ON CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. APPROVAL of the request of the applicant "SHARRI" LLC, for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.3599-0,3601-0 and 03901-0-5-0 CA Srecke, with an installed capacity of 95 kW, in Municipality of Prizren.
- **II.** The applicant "SHARRI" LLC, with electric meter registration number DPZ 9059016, **is OBLIGED** to submit a request at KEDS JSC for technical admission of energy facility, following the construction of new generation capacities for self-consumption.
- **III.** ERO shall consider the project as finalized from the date of technical admission, based on the Electro-Energetic Consent, issued by KEDS JSC.
- IV. The applicant "SHARRI" LLC shall bond a self-generation agreement with the supplier with whom it has bonded an electricity supply contract, following the confirmation of technical admission by KEDS JSC., in accordance with Article 18, paragraphs 1 and 2 of Rule No. 10/2017 on Support Scheme.

Reasoning





- ERO, on 18.04.2023, received from the applicant "SHARRI" LLC the application on obtaining the decision for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.3599-0,3601-0 and 03901-0-5-0 CA Srecke, with an installed capacity of **95 kW**, in the Municipality of Prizren.
- The applicant, along with the application, also attached evidence from KEDS on annual energy consumption, evaluation of annual production in kW/h of the installed equipment, Electro-Energetic Consent no. 2576 dated on 28.03.2023, issued by KEDS JSC., and the Ruling 04 no. 353/01-45789/23, dated on 12.04.2023, issued from the Directorate for Urbanization and Spatial Planning of the Municipality of Prizren.
- ERO Board, following the analysis of the request of the applicant "SHARRI" LLC, and attached evidence, for construction of new generation capacities for self-consumption from solar/photovoltaic panels, to be placed on the roof of the facility in the cadastral area no.3599-0,3601-0 and 03901-0-5-0 CA Srecke, with an installed capacity of <u>95 kW</u>, in Municipality of Prizren, evaluated them and considered that all relevant evidence on issuance of the decision for construction of new generation capacities for self-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory part of this decision, decided as in the enacting clause of this decision.
- V. The Decision is issued and published in official languages of the Republic of Kosovo
- **VI.** This Decision shall enter into force on the date of approval by the Board and shall be published on ERO's official website.

Legal advice: The party dissatisfied with this Decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of this Decision or the date of its publication on ERO's website, whichever occurs last.
