### The Board of Energy Regulatory Office,

#### Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 26, Article 28, paragraph 2, subparagraph 2.11, Article 30 and Article 32 of the Law on Energy Regulator (Law no.05/L-084);
- Provisions of Article 3, paragraph 1, sub-paragraph 1.11, Article 4, Article 7, Article 8 and Article 15 of the Rule no. 07/2017 on Licensing of Energy Activities in Kosovo;
- Provisions of Article 23 and Article 75 of the Law no.06/L-016 on Business Organizations;
- Application with attached documents, dated on 06 September 2022, respectively 07.02.2023 on licensing of electricity wholesale supply (trade) activity, submitted by the company Danske Commodities Kosovo LLC., address: Qyteza Pejton, St.Mujo Ulqinaku, no.5, Ap.10, Pristina, 10000, Republic of Kosovo,

in the session held on 05 May 2023 issued the following:

### DECISION

- I. EXTENSION of the electricity supply (trade) license to the company Danske Commodities Kosovo LLC, with license number ZRRE/Li\_39/17 for a five (5) year period, starting from 22 April 2023 until 21 April 2028.
- II. The company Danske Commodities Kosovo LLC is obliged to submit to the Regulator any document issued by different institutions to Danske Commodities Kosovo LLC, which can have an impact in the validity or validity period of the issued license as well as any other document which may be different from the ones submitted during the course of application for obtaining the license.

## Reasoning

- Energy Regulatory Office (hereinafter: the Regulator), on 06 September 2022, in electronic form and on 07 February 2023 through the administration of the Regulator (no.055/23) received from representatives of Danske Commodities Kosovo LLC the application with relevant evidence for licensing of electricity supply (trade) activity
- o For the licensing of this activity, the Regulator has evaluated that the company in question has acted in accordance with the legislation in force by submitting to the Regulator the evidence/requests and other data specified in the licensing application.





- According to Article 6 of the Rule on Licensing of Energy Activities in Kosovo, the company Danske Commodities Kosovo LLC, on 01.02.2023 and 03.02.2023, has notified the interested parties through newspapers that it has submitted an application to the Regulator for licensing of electricity wholesale supply (trade) activity and that the application is in the final stage for obtaining the license.
- According to Article 6 of the above-mentioned Rule, interested parties have the right to object to the application, if they testify to any irregularity thereof within eight (8) calendar days, from the date when the notice was published in the newspaper. The regulator did not receive any objections submitted by interested parties for this application.
- The Regulator, in line with Article 7 of the Rule on Licensing of Energy Activities in Kosovo, takes a formal decision on each license application within sixty (60) calendar days, from the date it considers the application complete.
- Following the submission by the company in question of all the documents and evidence required according to the instructions of the Regulator, the application is considered complete, so the Board of the Regulator based on the legal provisions mentioned in the introductory section of this decision, has decided as in the enacting clause of this decision.
- Danske Commodities Kosovo LLC is licensed by ERO from 22.04.2013 until 22.04.2018 and was extended the license from 22.04.2018 until 21.04.2023.
- The license issued on <u>22.04.2013</u> (license number ZRRE/Li\_39/13), modified on 10.05.2017 (license number ZRRE/Li\_39/17), extended from 22.04.2018 until 21.04.2023 <u>shall continue to be valid for a period of five (5) years</u>, until **21 April 2028** and can be extended if the licensee applies for license extension no later than six (6) months prior to the expiry of the license term and fulfils the criteria for license extension, in line with Article 32 of the Law on Energy Regulator as well as respective provisions of the Rule on Licensing of Energy Activities in Kosovo.
- III. The electricity wholesale supply (trade) license allows the licensee to carry out the above-mentioned activity of electricity in Kosovo, in line with the license and other applicable legislation.
- IV. The decision is issued and published in the official languages in the Republic of Kosovo.
- **V.** The decision enters into force on the date of approval by the Board of the Regulator and will be published in the official website of the Regulator.





**Legal advice:** The party dissatisfied with this decision may initiate an administrative dispute at the competent court, within thirty (30) days following the receipt of this decision or its publication on ERO's website, whichever occurs last.
