- Article 12, Article 14 and Article 17 of the Law on Energy (No. 05/L-081);
- Article 4, Article 5, Article 6, Article 7, Article 8, Article 11, Article 12, Article 13, Article 16, Article 17, Article 18, Article 19, paragraph 1 and Article 20 of the Rule no. 03/2022 on Authorization Procedure for Construction of Energy Projects;
- Application for authorization for construction of new generation capacities for electricity generation from solar/photovoltaic panels, with an installed capacity of 6 MW, CA Kodra e Hutit, Municipality of Gjakova, dated on 19.05.2023, prot. no. 268/23, of the company "Energy Development Group - Kosova" L.L.C., having its address at St. R Madanaj, nn, Gjakovë, Republic of Kosovo; and
- Decisions, permits and consents issued by relevant institutions, as in Appendix II of this decision,

in the session held on 18 August 2023 issued the following:

## D E C I S I O N O N I S S U A N C E O F A U T H O R I Z A T I O N

- I. **APPROVAL – and issuance of the AUTHORIZATION** to the company "Energy Development Group - Kosova" L.L.C. with Unique Identification Number (UIN) 810862179 for construction of new generation capacities for the production of electricity from solar/photovoltaic panels, with an installed capacity of 6 MW, in cadastral area no. P-70705041-00070-2 and P-70705041-00071-20 CA Kodra e Hutit all in an area of  $S=6,80,75$  m<sup>2</sup>, according to the **DECISION ON CONSTRUCTION PERMIT** no. 07/351/02-28581/2022 dated on 18.05.2023 for construction of the photovoltaic plant (solar park) for electricity generation with an installed capacity of 6 MW, according to the amendment of the construction permit in the cadastral parcel with no. P-70705041-00070-2 and P-70705041-00071-20 CA Kodra e Hutit issued by the Directorate for Urbanization and Environmental Protection of the Municipality of Gjakova.
- II. The company "Energy Development Group - Kosova" L.L.C. is **OBLIGED** that within thirty (30) days from the date of issuance of this decision, to submit a bank guarantee in the amount of 7% of the value of the project, issued by a commercial bank licensed in the Republic of Kosovo, with validity covering the period of twelve (12) months according to the Dynamic Implementation Plan submitted by the applicant.



- III. The bank guarantee according to point II. of this decision, will be in the amount of 335,615.00€ (three hundred thirty-five thousand six hundred and fifteen euros), according to the value of the project presented with the Business Plan, and in case the bank guarantee is not submitted to the ERO within the legal term according to the provision under point II. of this decision, **this Decision on Authorization will be suspended and simultaneously revoked.**
- IV. The authorization, according to the provision under point I. of this decision, is issued to the company "Energy Development Group - Kosova" LLC, according to the Dynamic Implementation Plan, and it is obliged to build, within this period, the new generating plants for electricity generation from solar/photovoltaic panels.
- V. ERO will consider the project finalized from the date of issuance of the Occupancy Certificate issued by the competent body according to the Law on Construction.
- VI. The Environmental Permit issued by MESPI for the Energy project for the new generating capacities shall be criteria for the commencement of commercial operation.
- VII. The company "Energy Development Group - Kosova" L.L.C., prior to entry into operation, shall obtain from ERO an electricity generation license for the energy project.

### **Reasoning**

- ERO, on 19.05.2023, from the company "**Energy Development Group - Kosova**" L.L.C. received the application on obtaining the authorization for construction of new generation capacities for electricity generation from solar/photovoltaic panels with an installed capacity of 6 MW, in the cadastral areas in Bec, with no. P-70705005: 1030-0, 1031-1, 1032-0, 1033-0, 1035-0, 1036-0, 1037-0, 1038-0, 1040-0, 1041-0, 1043-0, 1044-0, 1045-0, 1046-0, 1047-0, 1048-9 and 10, and the cadastral parcel in Vraniq with no. P 70705012- 000K-5 ZK Vraniq, all within the area of S=2,450,280 m2, Municipality of Gjakova, Republic of Kosovo.
- The company "Energy Development Group - Kosova" L.L.C., on 03.07.2023, published the written notice on written electronic media, informing all the stakeholders that in line with Article 8 of the Rule on Authorization, applied at ERO, following the completion of the documentation on obtaining the authorization, through which the interested parties were notified that they can submit their eventual remarks in relation to this application, to ERO, within eight (8) days from the date of publication.
- ERO, on 21.06.2023, published the Public Notice in ERO's website, in line with Article 13, par. 4 of the rule in force.
- ERO, within this term and until the review of the application by ERO Board has not received any remarks or complaints. The applicant has also submitted the payment of the application review tax on 26.06.2023 at ERO.

ERO, following the analysis of the submitted evidence in line with the application for authorization and their evaluation from ERO, considered that the application "Energy



Development Group - Kosova” L.L.C. has fulfilled the administrative requirements according to the application as well as the legal ones to be handled and obtain the authorization for construction of new generation capacities for electricity generation from solar/photovoltaic panels, with an installed capacity of 6 MW, in the cadastral parcels P-70705041-00070-2 and P-70705041-00071-20 CA Kodra e Hutit, all within an area of S=6,80,75 m<sup>2</sup>, according to the DECISION ON CONSTRUCTION PERMIT No. 07/351/02-28581/2022, dated on 18.05.2023, issued by the Directorate of Urbanization and Environmental Protection of the Municipality of Gjakova; Environmental Consent no. 22/7707, date don 03.02.2023, issued by the Ministry of Environment, Spatial Planning and Infrastructure; Electro-energetic Consent no. 3594, dated on 02.05.2023, issued by KEDS JSC, Evidence on Ownership Rights (Contracts on the use of land); Declaration on the sale of energy; Agreement on the sale of energy with private suppliers; Technical and financial feasibility study; Business Plan and Dynamic Plan of Realization for the period of twelve (12) months.

- The project is in line with the Energy Strategy and relevant documentations for development of Renewable Energy Sources.
- Following the evaluation of the attached evidence, permits, approvals and decisions issued by relevant institutions, and based on legal provisions mentioned in the introductory part of this decision, ERO decided as in the enacting clause of this decision.

**VIII.** The decision is issued and published in official languages of the Republic of Kosovo.

**IX.** The decision enters into force on the date of approval by the Board and will be published on ERO’s official website.

**Legal advice:** The party dissatisfied with this decision may initiate an administrative dispute at the Competent Court, within thirty (30) days from the date of receipt of the decision or the date of its publication on ERO’s website, whichever occurs last.

## APPENDIX I

- The Energy Regulatory Office (ERO) exercising its competences granted under Article 43 of the Law on the Energy Regulator and in line with Article 17 of the Rule No. 03/2022 on the Authorization Procedure for Construction of Energy Projects, to the company “Energy Development Group - Kosova” L.L.C., having its address at Madanaj Street, nn, Gjakovë, Republic of Kosovo, on 18 August 2023, issued **the following**:

### AUTHORIZATION

1. For construction of new generation capacities for electricity generation from solar/photovoltaic panels, with an installed capacity of **6 MW**, in cadastral areas with No. P-70705041-00070-2 and P-70705041-00071-20 CA Kodra e Hutit all in an area of  $S=6,80,75 \text{ m}^2$ , according to the **DECISION ON CONSTRUCTION PERMIT (Amendment of the Construction Permit)** No. 07/351/02-28581/2022, dated on 18.05.2023 issued by the Directorate of Urbanization and Environmental Protection, of the Municipality of Gjakova.
2. Hereby, “Energy Development Group - Kosova” L.L.C.. Company, is authorized to construct generation capacities in the above-mentioned location, in accordance with terms and conditions determined in the Rule on Authorization.
3. This authorization is issued according to the Dynamic Plan of Realization, starting from the date of its issuance. ERO, upon the request of the party may extend the validity of the Authorization, in accordance with applicable legislation.
4. The Authorized Party, during the entire validity period of this Authorization, must fulfil the following:
  - 2.1. All conditions set out under this authorization, and
  - 2.2. All conditions set out under applicable legislation in Kosovo, including those on environment.
5. In case the authorized party goes bankrupt before the construction of the authorized generation plant, then this authorization shall be suspended and shall remain as such until ERO determines that the conditions for withdrawal of suspension have been achieved. As long as this authorization is suspended, the entire further works for constructing the generation plant are to be stopped. Otherwise, administrative measures and fines set out under the applicable legislation may be undertaken against the authorized party.
6. The validity of this authorization shall automatically expire as per Article 19, par. 1 of the Rule no. 03/2022 on Authorization Procedure for Construction of Energy Projects or upon the expiry of the additional term set by ERO.
7. In case the authorized party violates any of the conditions of this authorization, and of the applicable legal provisions, ERO shall suspend the authorization in accordance with the provisions of Rule on Authorization Procedure for construction of New Capacities. From the date this authorization is suspended, the entire further works for constructing the generating establishment are to be stopped. In case of noncompliance, administrative measures and fines set out under the applicable legislation may be undertaken against the authorized party.
