The Board of Energy Regulatory Office,

Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 15, Article 26, paragraph 1, sub-paragraph 1.2, Article 28, paragraph 2, sub-paragraph 2.11, Article 30 and Article 32 of the Law on Energy Regulator (Law no. 05/L-084);
- Provisions of Article 32 of the Law on Electricity (Law no. 05/L-085);
- Provisions of Article 3, paragraph 1, sub-paragraph 1.11, Article 4, Article 6, Article 7, Article 8 and Article 15 of the Rule no. 07/2017 on Licensing of Energy Activities in Kosovo;
- Application with attached evidence, dated on **15.06.2023** on licensing of electricity wholesale supply (trade) activity, submitted by the company **SOLE 24 LLC**, **Branch in Kosovo**, **having its address at: St. Idriz Gjilani**, **Entry 11**, **no. 1P**, **10000**, **Pristina**, **Republic of Kosovo**,

in the session held on 21 September 2023 issued the following:

DECISION

- I. ISSUANCE OF THE LICENSE for electricity wholesale supply (trade) to the company SOLE 24 LLC Branch in Kosovo, with license number ZRRE/Li_93/23 for a period of five (5) years which shall be valid from 21.09.2023 until 20.09.2028.
- II. The company is **obliged** to submit to the Regulator any document issued by different institutions to **SOLE 24 LLC- Branch in Kosovo**, which can have an impact on the validity and validity period of the issued license as well as any document which is different from the ones submitted during the course of application for obtaining the license.

Reasoning

- The Energy Regulatory Office (the Regulator), on 15.06.2023, received from representatives of the company SOLE 24 LLC Branch in Kosovo the application with the relevant evidence for licensing of the electricity wholesale supply (trade) activity in Kosovo.
- The Regulator evaluated that the company in question has acted according to the instructions
 of the Regulator and the requirements set forth in the application for licensing of the electricity
 wholesale supply (trade) activity in Kosovo and other legislation in force.





- Based on Article 6 of the Rule on Licensing of Energy Activities in Kosovo, the company **SOLE**24 LLC Branch in Kosovo, on 02.08.2023 has notified the interested parties through the newspaper (portals in the absence of newspapers) that it has submitted to the Regulator the application for licensing of the electricity wholesale supply (trade) activity and that the application is in the final stage for obtaining the license. The interested parties were entitled to object to the application, if they could testify to any irregularity within eight (8) calendar days, from the date when the announcement was published in the newspaper (potal). The Regulator has not received any objections made by interested parties regarding this application.
- The Regulator, in line with Article 7 of the Rule on Licensing of Energy Activities in Kosovo issues
 a formal decision on each license application within sixty (60) calendar days, from the date
 when the application is deemed complete.
- The license issues according to this decision shall continue to be valid for the period according to point I. of the enacting clause of this decision, with the possibility of extension, if the licensee applies for license extension no later than six (6) months prior to the expiry of the license term, in line with Article 32 of the Law on Energy Regulator and other legislation in force.
- The Regulator, following the evaluation of the application and other evidence attached to the
 application of the company SOLE 24 LLC Branch in Kosovo, and based on legal provisions
 mentioned in the introductory section of this decision, has decided as in the enacting clause to
 this decision.
- III. This decision is issued in official languages of the Republic of Kosovo.
- **IV.** The decision enters into force on the date of approval by the Board of the Regulator and will be published on the official website of the Regulator.

Legal advice: The party dissatisfied with this decision may initiate an administrative dispute at the competent court within thirty (30) days from the date of receipt of the decision or the date of its publication on ERO's website, whichever occurs last.
