The Board of Energy Regulatory Office,

Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 15 and Article 26 of the Law on Energy Regulator no. 05/L-084;
- Provisions of Article 20 of the Law on Thermal Energy no. 05/L-052; and
- Amendment of the Heat Supply Agreement between KEK Generation JSC and Termokos JSC, submitted for approval at ERO, on 10 October 2023.

in the session held on 17 October 2023, issued the following:

## DECISION

- I. **APPROVAL** of the Annex for determination of the price of thermal energy from co-generation of the “Basic Agreement for Heat Supply”, concluded on 24.12.2014, no. 52 between KEK- Kosovo Energy Corporation JSC and DH Termokos JSC.

### Reasoning

- On 10 October 2023, Energy Regulatory Office (ERO) RECEIVED THE “Annex Agreement on Determination of Thermal Energy Price for Heat Supply”, which is concluded between KEK JSC – DH Termokos JSC, on 09 October 2023.
- The amendments of the Annex Agreement on Determination of Thermal Energy Price contain:
  - Article 1: which determines the validity period of the annex agreement, from 15 October 2023 until 15 April 2024,
  - Article 2: through which two (2) paragraphs of appendix IV of the basic agreement are amended. This amendment derives from the deregulation of electricity generator (KEK JSC). More concretely, thermal energy prices from co-generation in TPP Kosova B are referred to electricity price that KEK Generation provides to the Universal Service Supplier (USS) of electricity in the amount of 29.50 €/MWh, as well as the additional cost of 0.23 €/MWh to cover the cost of electricity consumption at the heat extraction station in TPP Kosova B (HES), based on the Methodology previously agreed between KEK – DH Termokos – ERO.
  - Article 3, through which the parties agree that the base price, re-calculated according to Article 2 will be 29.73 €/MWh.
  - Article 4, through which the parties agree that for the period according to Article 1, the thermal energy price shall be at the level 1.36 €/MWh whereas for the electric capacity will be at the level of 20.81 €/MWh/h.



- Other provisions of the basic agreement, signed on 24 December 2014 and approved by ERO on 23 December 2014, by Decision V\_677\_2014 shall remain in force.
- Based on the legal provisions mentioned in the introductory section as well as the review of the annex in question, ERO Board has decided as in the enacting clause of this decision.

II. The decision is issued in official languages of the Republic of Kosovo.

III. The decision enters into force on the date of approval by ERO Board and will be published on ERO's official website.

**Legal advice:** The party dissatisfied with this decision may initiate an administrative dispute at the competent court, within thirty (30) days from the receipt of the decision or its publication on ERO's website, whichever occurs last.
