The Board of Energy Regulatory Office,

Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 15, Article 26, paragraph 1, sub-paragraph 1.2, Article 28, paragraph 2, sub-paragraph 2.11, Article 30 and Article 32 of the Law on Energy Regulator (Law no. 05/L-084);
- Provisions of Article 32 of the Law on Electricity (Law No. 05/L-085);
- Provisions of Article 3, paragraph 1, sub-paragraph 1.11, Article 4, Article 6, Article 7, Article 8 and Article 15 of the Rule no. 07/2017 on Licensing of Energy Activities in Kosovo;
- Application with attached documents, dated on **27.04.2023**, on licensing of electricity wholesale supply (trade) activity, submitted by the company **Yildirim Energy Europe LLC, having its address at: St. Besim Mala no. 227 13000 Gillogoc, Republic of Kosovo.**

in the session held on **01 December 2023** issued the following:

DECISION

- I. **ISSUANCE OF THE LICENSE for wholesale supply (trade) of electricity** to the company **Yildirim Energy Europe LLC**, with license number **ZRRE/Li_92/23**, for a period of five (5) years and shall be valid from **01.12.2023** until **30.11.2023**.
- II. The company is **obliged** to submit to the Regulator any document issued by different institutions to **Yildirim Energy Europe LLC** which can have an impact on the validity or validity period of the issued license, as well as any other document that can be different from the one submitted during the course of application for obtaining the license.

Reasoning

- o Energy Regulatory Office (the Regulator), on 27.04.2023 received from representatives of the company **Yildirim Energy Europe LLC** the application with relevant evidence of licensing of the **electricity wholesale supply (trade) activity** in Kosovo.
- o The Regulator evaluated that the company in question has acted in accordance with the instructions of the Regulator and the requirements foreseen in the application for licensing of the electricity wholesale supply (trade) activity in Kosovo and other legislation in force.
- o According to Article 6 of the Rule on Licensing of Energy Activities in Kosovo, the company **Yildirim Energy Europe LLC**, on **07.11.2023** has notified the interested parties through the newspaper (portals in the absence of newspapers) that it has submitted to the Regulator the application for licensing of the electricity wholesale supply (trade) activity and that the application is in the final stage for obtaining the license. The interested parties had the right to object to the application, if they could testify to any irregularity within eight (8) calendar



days, from the date when the notice was published in the newspaper (portal). The Regulator has not received any objections submitted by interested parties regarding this application.

- The Regulator, in line with Article 7 of the Rule on Licensing of Energy Activities in Kosovo, issues a formal decision for each license application within sixty (60) calendar days, from the date when the application is deemed complete.
- The license issues in line with this decision shall continue to be valid for the period according to the point I. of the enacting clause to this decision, with the possibility of extension, if the licensee applied for license extension **no later than six (6) months** prior to the expiry of the license term, in line with Article 32 of the Law on Energy Regulator and other legislation in force.
- The Regulator, following the evaluation of the application and other evidence attached to the application of the company **Yildirim Energy Europe LLC** and based on legal provisions mentioned in the introductory section of this decision, decided as in the enacting clause to this decision.

I. The decision is issued in official languages of the Republic of Kosovo.

II. The decision shall enter into force on the date of approval by the Board of the Regulator and will be published on the official website of the Regulator.

Legal advice: The party dissatisfied with this decision may initiate an administrative dispute at the competent court within thirty (30) days from the date of receipt of the decision or the date of its publication on the electronic website of the Regulator, whichever occurs last.
