- Thermal Energy Pricing Rule;
- Decision for DH Gjakova JSC, no. V_XXX_2023 on Maximum Allowed Revenues (MAR); and
- Application/request of the Public Enterprise – District Heating (DH) Gjakova JSC on determination of Maximum Allowed Revenues and Thermal Energy Tariffs, submitted on 18 August 2023, within the thermal energy tariff review, with the relevant explanatory documentation;

in the session held on 1 December 2023 issued the following:

DECISION

- I. **APPROVAL** of thermal energy tariffs for final customers of the District Heating (DH) Gjakova JSC for the heating season 2023/2024.
- II. The structure of thermal energy tariffs for DH Gjakova JSC, for the heating season 2023/2024 is provided in table 1 below:

- III. Within five (5) working days following the announcement and publication of this decision in the electronic website of ERO, DH Gjakova shall publish the structure of thermal energy tariffs, as



determined in table 1 of this decision, on its electronic website and at least one media with wide circulation in Kosovo.

- IV.** This decision will be implemented by the enterprise DH Gjakova JSC, starting from the date of commencement of the heating season 2023/2024 until the next tariff review.

REASONING

- Energy Regulatory Office (ERO), on 18 August 2023, from DH Gjakova JSC received the application/request for review and approval of thermal energy Maximum Allowed Revenues and tariffs.
 - ERO, upon the determination of thermal energy tariffs, has taken into consideration the documents issued and published on the official website of ERO, as follows:
 - The submitted data and information, attached to the request for review of Maximum Allowed Revenues and tariffs, dated on 18 August 2023;
 - Written comments, issued by ERO on 11 September 2023, specifying the requirements for correction, improvement and supplement of the submitted data and information;
 - The data and information corrected and supplemented according to the written comments of ERO, re-submitted by DH Gjakova JSC, on 18 September 2023;
 - The Reports on Public Consultation: Preliminary Evaluation on Determination of Maximum Allowed Revenues and Thermal Energy Tariffs for DH Gjakova JSC- heating season 2023/2024;
 - During the public consultation period (2 November – 16 November 2023) ERO has not received any comments regarding the reports in question;
 - The final Report on Determination of Maximum Allowed Revenues for DH Gjakova JSC – heating season 2023/2024;
 - Final Report on Determination of Thermal Energy Tariffs for DH Gjakova JSC- heating season 2023/2024;
 - The Board of the Regulator, following the evaluation and analysis of relevant reports as well as based on the legal provisions mentioned in the introductory section of this decision, has decided as in the enacting clause to this decision.
- V.** The decision is issued and published in the official languages of the Republic of Kosovo.
- VI.** The decision enters into force on the date of approval by ERO Board and will be published on the official website of ERO.



Legal advice: The party dissatisfied with this decision may initiate an administrative dispute at the competent court, within thirty (30) days from the date of receipt of the decision or the date of its publication on ERO's website, whichever occurs last.
