- Article 9 of Rule no. 03/2022 on Authorization Procedure for Construction of Energy Projects, issued by ERO Board;
- Articles 3, 4, 5 and 7 of Rule no. 03/2023 on Prosumers of Renewable Sources, issued by ERO Board;
- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, with an installed capacity of **10 kW**, in Municipality of Gjilan, received on 08.12.2023, from the natural person applicant "Merita Salihu Kadriu", having its address at "Karavicë", Municipality of Gjilan, Republic of Kosovo,

in the session held on 13 December 2023 issued the following:

DECISION

ON CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. APPROVAL of the request and status of the prosumer for the applicant "Merita Salihu Kadriu", for construction of new generation capacities for self-consumption, from solar/photovoltaic panels with an installed capacity of **10 kW**, in Municipality of Gjilan.
- II. The applicant "Merita Salihu Kadriu", with electric meter registration number DGL 9058901, is OBLIGED to submit a request at KEDS JSC for technical admission of energy facility, following the construction of new generation capacities for self-consumption.
- **III.** ERO shall consider the project as finalized from the date of technical admission, based on the electro-energetic consent, issued by KEDS JSC.
- IV. The applicant "Merita Salihu Kadriu" shall bond a self-generation agreement with the supplier with whom it has bonded an electricity supply contract, following the confirmation of technical admission by KEDS JSC., in accordance with Article 7, paragraphs 5 and 6 of Rule no. 03/2023 on Prosumers of Renewable Sources.

Reasoning





- ERO, on 08.12.2023, received from the applicant "Merita Salihu Kadriu" the application for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, with an installed capacity of **10 kW**, in the Municipality of Gjilan.
- The applicant, along with the application, also attached evidence from KEDS on annual energy consumption, evaluation of annual production in kW/h of the installed equipment and electro-energetic consent no. 10809 dated on 06.12.2023, issued by KEDS JSC, and the Decision no.12/2023, dated on 28.03.2023, issued by Directorate for Urbanization, Planning and Environmental Protection of the Municipality of Gjilan.
- ERO Board, following the analysis of the request of the applicant "Merita Salihu Kadriu", and attached evidence, on obtaining the status of the prosumer for construction of new generation capacities for self-consumption from solar/photovoltaic panels, with an installed capacity of <u>10</u>
 <u>kW</u>, in Municipality of Gjilan, evaluated them and considered that all relevant evidence on issuance of the decision for construction of new generation capacities for self-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory part of this decision, decided as in the enacting clause of this decision.
- V. The decision is issued and published in official languages of the Republic of Kosovo
- VI. This decision shall enter into force on the date of approval by the Board and will be published on ERO's official website.

Legal advice: The party dissatisfied with this decision may initiate an administrative dispute at the competent court, within thirty (30) days from the date of receipt of this decision or the date of its publication on ERO's website, whichever occurs last.
