- Article 9 of Rule no. 03/2022 on Authorization Procedure for Construction of Energy Projects, issued by ERO Board;
- Articles 3, 4, 5 and 7 of Rule no. 03/2023 on Prosumers of Renewable Sources, issued by ERO Board;
- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, with an installed capacity of 2.5 kW, in Municipality of Prishtina, received on 11.12.2023, from the natural person applicant "Valza Kika Salihu", having its address at "Nicë Neighbourhood", Municipality of Prishtina, Republic of Kosovo,

in the session held on 13 December 2023 issued the following:

DECISION

ON CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. APPROVAL of the request and status of the prosumer for the applicant "Valza Kika Salihu", for construction of new generation capacities for self-consumption, from solar/photovoltaic panels with an installed capacity of **2.5 kW**, in Municipality of Prishtina.
- II. The applicant "Valza Kika Salihu", with electric meter registration number DPR 90088817, is OBLIGED to submit a request at KEDS JSC for technical admission of energy facility, following the construction of new generation capacities for self-consumption.
- **III.** ERO shall consider the project as finalized from the date of technical admission, based on the electro-energetic consent, issued by KEDS JSC.
- **IV.** The applicant "Valza Kika Salihu" shall bond a self-generation agreement with the supplier with whom it has bonded an electricity supply contract, following the confirmation of technical admission by KEDS JSC., in accordance with Article 7, paragraphs 5 and 6 of Rule no. 03/2023 on Prosumers of Renewable Sources.

Reasoning





- ERO, on 11.12.2023, received from the applicant "Valza Kika Salihu" the application for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, with an installed capacity of 2.5 kW, in the Municipality of Prishtina.
- The applicant, along with the application, also attached evidence from KEDS on annual energy consumption, evaluation of annual production in kW/h of the installed equipment and electroenergetic consent no. 10813 dated on 06.12.2023, issued by KEDS JSC.
- ERO Board, following the analysis of the request of the applicant "Valza Kika Salihu", and attached evidence, on obtaining the status of the prosumer for construction of new generation capacities for self-consumption from solar/photovoltaic panels, with an installed capacity of <u>2.5</u>
 <u>kW</u>, in Municipality of Prishtina, evaluated them and considered that all relevant evidence on issuance of the decision for construction of new generation capacities for self-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory part of this decision, decided as in the enacting clause of this decision.
- V. The decision is issued and published in official languages of the Republic of Kosovo
- VI. This decision shall enter into force on the date of approval by the Board and will be published on ERO's official website.

Legal advice: The party dissatisfied with this decision may initiate an administrative dispute at the competent court, within thirty (30) days from the date of receipt of this decision or the date of its publication on ERO's website, whichever occurs last.
