The Board of Energy Regulatory Office,

Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 15, Article 26, paragraph 1, sub-paragraph 1.2, Article 28, paragraph 2, sub-paragraph 2.10, Article 30 and Article 32 of the Law on Energy Regulator (Law no. 05/L-084);
- Provisions of Article 33 of the Law on Electricity (Law no. 05/L-085);
- Provisions of Article 3, paragraph 1, sub-paragraph 1.10, Article 4, Article 6, Article 7, Article 8 and Article 15 of the Rule no. 07/2017 on Licensing of Energy Activities in Kosovo;
- Application with attached documents, dated on 30.10.2023 on licensing of electricity supply activity, submitted by the company **INFINIT POWER SOLUTION LLC (business name) INIFINIT POWER SOLUTION (trade name), having its address: St: Garibaldi 17/5, Entry 1, Pristina, 10000, Republic of Kosovo,**

in the session held on 28.12.2023 issued the following:

DECISION

- I. **ISSUANCE** of the electricity supply **LICENSE** to the company **INFINIT POWER SOLUTION LLC**, with license number **ZRRE/Li_95/23**, for the time period from **28.12.2023** until **27.12.2028**.
- II. The company is **obliged** to submit to the Regulator any document issued by different institutions to **INFINIT POWER SOLUTION LLC** which can have an impact in the validity or validity period of the issued license, as well as any document which can differ from the ones submitted during the course of application for obtaining the license.

Reasoning

- Energy Regulatory Office (the Regulator), on 30.10.2023, received from the company **INFINIT POWER SOLUTION LLC** the application with relevant evidence on licensing of electricity **supply** activity in Kosovo.



- The Regulator evaluated that the company in question has acted in line with the instructions of the Regulator and the requirements foreseen in the application for licensing of electricity supply activity in Kosovo and other legislation in force.
- According to Article 6 of the Rule on Licensing of Energy Activities in Kosovo, the company **INFINIT POWER SOLUTION LLC**, on **29.11.2023** notified the stakeholders through newspaper (portals) that it has submitted to the Regulator an application for licensing of electricity supply activity and that the application is in the final stage for obtaining the license.
- According to Article 6 of the above-mentioned rule, the stakeholders were entitled to contradict the application if they could prove any irregularity therein, within eight (8) calendar days, from the date when the notice is published on the newspaper. The Regulator did not receive any contradiction submitted by the stakeholders on this application.
- The Regulator, in line with Article 7 of the Rule on Licensing of Energy Activities in Kosovo, issues a formal decision for each license application within sixty (60) calendar days, from the day when the application is deemed complete.
- **INFINIT POWER SOLUTION LLC** has an electricity supply (trade) license, issued by the Board of the Energy Regulator, with license number ZRRE/Li_94/23, for the five (5) year period, from 21.09.2023 until 20.09.2028.
- The license issued according to this decision shall continue to be valid for the period according to point I. of the enacting clause of this decision, with a possibility of renewal, if the licensee applies for license extension no later than six (6) month prior to the expiry of the license term, in line with Article 32 of the Law on Energy Regulator and other legislation in force.
- The Regulator, following the evaluation of the application and other evidence attached to the application of the company **INFINIT POWER SOLUTION LLC** and based on legal provisions mentioned in the introductory section of this decision, decided as in the enacting clause to this decision.

III. The decision is issued in official languages of the Republic of Kosovo.

IV. The decision enters into force on the date of approval by the Board of the Regulator and will be published on the official site of the Regulator.



Legal advice: The party dissatisfied with this decision may initiate an administrative dispute at the competent court, within thirty (30) days from the date of receipt of the decision or the date of its publication on the website of the Regulator, whichever occurs last.
