- Provisions of Article 28, Paragraph 1.28 of the Law on Electricity (Law No. 05/L-085);
- Provisions of Article 10 of the Law on Energy (Law No. 05/L-081);
- Provisions of Article 10 of the Distribution System Operator License,
- The provisions of Article 1, paragraph 3 of the Rule for the Evaluation of Capital Projects in the Transmission and Distribution Network in the Electricity Sector,
- The provisions of Article 2, paragraph 2 as well as the provisions of Article 6 of Appendix 3 of the Rule on DSO Income,
- The request of KEDS JSC., dated 06.06.2023 for review and approval of the One (1) year Investment Plan of the Distribution System Operator (DSO) for the year 2023,

in the session held on July 5, 2023, issued this:

## DECISION

- **I. APPROVED** The One (1) year Investment Plan of the Distribution System Operator (KEDS) for the year 2023.
- **II. OBLIGATED** Distribution System Operator KEDS JSC. to implement the projects planned according to this plan for safer operation of the Distribution System.

## Justification

- The Energy Regulatory Office (ERO) on 06.06.2023 has accepted the request for review and approval of the one (1) year Investment Plan of the Distribution System Operator for the year 2023.
- ERO, after the initial review of the one (1) year Investment Plan of the Distribution System Operator for the year 2023, has given the initial comments, which on 29.06.2023 it has sent to DSO.



- ERO dated 21.06.2023, has published the one (1) year Investment Plan for public discussion to receive comments, suggestions and evaluations from licensees as well as stakeholders.
- DSO on 04.07.2023 has sent the answers to the comments of ERO regarding the one (1) year Investment Plan of the Distribution System Operator for the year 2023.
- DSO on 04.07.2023, also sent the one (1) year Investment Plan of the Distribution System Operator for 2023, revised after the supplementary comments of ERO.
- After the end of the public consultation, and after the inclusion of ERO's comments, the document has been prepared for review and approval, with the changes requested by ERO.
- The Board of ERO, after evaluating and analysing the one (1) year Investment Plan of the Distribution System Operator for 2023, has concluded that the legal requirements have been met, and has assessed that the projects included in the document are reasonable and necessary for the operation safety of the distribution system, therefore decided as in the provision of this Decision.
- **III.** The decision is issued and published in the official languages of the Republic of Kosovo.
- **IV.** The decision enters into force on the date of approval by the Board of the Office of the Regulator and will be published on the official website of the ERO.

**Legal advice:** Against this decision, the dissatisfied party can appeal to the Competent Court within thirty (30) days from the date of acceptance of the Decision or the date of publication of the Decision on the ERO website, whichever occurs last
