The Board of Energy Regulatory Office,

Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.5, paragraph 8, paragraph 9 and paragraph 10, Article 25, Article 26, paragraph 1, sub-paragraph 1.2 of the Law on Energy Regulator (Law no. 05/L-084);
- Provisions of Article 16, paragraph 1.11 of the Law on Electricity (Law no. 05/L-085);
- Provisions of Article 10 of the Law on Energy (Law no. 05/L-081);
- Provisions of Article 12 of the Transmission System Operator License, and
- Request of KOSTT JSC, with prot. no. 2275, dated on 09.11.2023, on review and approval of the Transmission Development Plan 2024-2033,

in the session held on 28.12.2023 issued the following:

DECISION

- I. **APPROVAL** - of the Transmission Development Plan for the period 2024-2033 of KOSTT JSC;
- II. The Transmission System and Market Operator (KOSTT) JSC is **OBLIGED** to implement the planned projects in accordance with the plan for safer functioning of the transmission system.

Reasoning

- Energy Regulatory Office (ERO), on 09.11.2023, received the request for approval of the Transmission Development Plan 2024-2033 of KOSTT JSC.
- ERO, following the evaluation of the Development Plan, initiated the public consultation to receive comments and suggestions and evaluations from the licensees and the stakeholders.
- Following the conclusion of the public consultation period and frequent meetings between ERO, KOSTT and KEDS in relation to harmonizing the plans, it was evaluated that all the required comments and justifications for review and approval have been included.



- ERO Board, following the evaluation and analysis of the Transmission Development Plan 2024-2033 concluded that the legal requirements have been fulfilled and evaluated that the projects included in the document are justifiable and required for the safe functioning of the transmission system therefore decided as in the enacting clause to this decision.

III. The decision is issued and published in official languages of the Republic of Kosovo.

IV. The decision enters into force on the date of approval by the Board of the Energy Regulatory Office and will be published on the official website of ERO.

Legal advice: The party dissatisfied with this decision may address it to the competent court within thirty (30) days from the date of receipt of the decision or the date of its publication on ERO's website, whichever occurs last.
