## The Board of Energy Regulatory Office,

Based on:

- Provisions of Article 9, paragraph 1, sub-paragraph 1.7, Article 15, paragraph 1, sub-paragraph 1.5, Article 25, Article 26, paragraph 1, sub-paragraph 1.2 of the Law on Energy Regulator (Law no. 05/L-084);
- Provisions of Article 16, paragraph 1.12 and paragraph 1.13 of the Law on Electricity (Law no. 05/L-085);
- Provisions of Article 12 of Transmission System Operator License, and
- Request of KOSTT JSC, with prot. no. 2463, dated on 01.12.2023 on review and approval of the Five
  (5) Year Transmission Development Plan 2024-2028,

in the session held on 28 December 2023 issued the following:

## DECISION

- I. APPROVAL- of the Five (5) Year Transmission Development Plan for the period 2024-2028 of KOSTT JSC.
- **II.** The Transmission System and Market Operator (KOSTT) JSC is OBLIGED to implement the planned projects according to this plan for safer functioning of the Transmission System.

## Reasoning

- Energy Regulatory Office (ERO), on 01.12.2023 received the request for review and approval of the Five (5) Year Transmission Development Plan for the period 2024-2028 of KOSTT JSC.
- ERO analysed the document and concluded that it is in line with the Ten (10) Year Transmission Development Plan, documentation on spatial planning, Distribution System Operator Development Plan, as well as the legal requirements.
- ERO, following the evaluation of the Development Plan, announced the commencement of public





consultation to receive comments, suggestions and evaluations from the licensees as well as stakeholders.

- Following the conclusion of the public consultation period and frequent meetings between ERO, KOSTT and KEDS related to harmonization of plans, KOSTT JSC, on 11.12.2023, submitted to ERO for review and approval the Five (5) Year Transmission Development Plan 2024-2028.
- ERO Board, following the evaluation and analysis of the Five (5) Year Transmission Development Plan 2024-2028 concluded that the legal requirements have been fulfilled and evaluated that the projects included in the document are reasonable and required for the safer functioning of the transmission system, therefore decided as in the enacting clause to this decision.
- **III.** The decision is issued and published in official languages of the Republic of Kosovo.
- **IV.** The decision enters into force on the date of approval by the Board of Energy Regulatory Office and will be published on the official website of ERO.

**Legal advice:** The party dissatisfied with this decision may address it to the competent court within thirty (30) days from the date of receipt of the decision or the date of its publication on ERO's website, whichever occurs last.
