- Article 9 of Rule no. 03/2022 on Authorization Procedure for Construction of Energy Projects, issued by ERO Board;
- Articles 3, 4, 5 and 7 of Rule no. 03/2023 on Prosumers of Renewable Sources, issued by ERO Board;
- Application for construction of new generation capacities for self-consumption from solar/photovoltaic panels, with an installed capacity of **5 kW**, in Municipality of Pristina, received on 15.01.2024, from the natural person applicant "LAVDIM HAMITI", having its address at "28 Nëntori", Municipality of Pristina, Republic of Kosovo,

in the session held on 29 January 2024 issued the following:

DECISION

ON CONSTRUCTION OF GENERATION CAPACITIES FOR SELF-CONSUMPTION

- I. **APPROVAL** of the request and status of the prosumer for the applicant "LAVDIM HAMITI", for construction of new generation capacities for self-consumption, from solar/photovoltaic panels with an installed capacity of **5 kW**, in Municipality of Pristina.
- II. The applicant "LAVDIM HAMITI", with electric meter registration number DPR – 90032822, GT 7/02, is **OBLIGED** to submit a request at KEDS JSC for technical admission of energy facility, following the construction of new generation capacities for self-consumption.
- III. ERO shall consider the project as finalized from the date of technical admission, based on the electro-energetic consent, issued by KEDS JSC.
- IV. The applicant "LAVDIM HAMITI" shall bond a self-generation agreement with the supplier with whom it has bonded an electricity supply contract, following the confirmation of technical admission by KEDS JSC., in accordance with Article 7, paragraphs 5 and 6 of Rule no. 03/2023 on Prosumers of Renewable Sources.

Reasoning



- ERO, on 15.01.2024, received from the applicant “LAVDIM HAMITI” the application for construction of new generation capacities for self-consumption, from solar/photovoltaic panels, with an installed capacity of **5 kW**, in the Municipality of Pristina.
- The applicant, along with the application, also attached evidence from KEDS on annual energy consumption, evaluation of annual production in kW/h of the installed equipment and electro-energetic consent no. 12571 dated on 29.12.2023, issued by KEDS JSC.
- ERO Board, following the analysis of the request of the applicant “LAVDIM HAMITI”, and attached evidence, on obtaining the status of the prosumer for construction of new generation capacities for self-consumption from solar/photovoltaic panels, with an installed capacity of **5 kW**, in Municipality of Pristina, evaluated them and considered that all relevant evidence on issuance of the decision for construction of new generation capacities for self-consumption have been fulfilled, therefore based on the legal provisions mentioned in the introductory part of this decision, decided as in the enacting clause of this decision.

V. The decision is issued and published in official languages of the Republic of Kosovo.

VI. This decision shall enter into force on the date of approval by the Board and will be published on ERO’s official website.

Legal advice: The party dissatisfied with this decision may initiate an administrative dispute at the competent court, within thirty (30) days from the date of receipt of this decision or the date of its publication on ERO’s website, whichever occurs last.
