The Board of Energy Regulatory Office,
Based on:

- Article 9, paragraph 1.7, Article 25 and Article 26, paragraph 1, sub-paragraph 1.2 of the Law on Energy Regulator no. 05/L-084;
- Rule no. 03/2023 on Prosumers of Renewable Sources;
- Article 28, paragraph 5 of the Rule on General Conditions of Energy Supply; and
- Request, dated on 12.01.2024, on approval of the new design of electricity invoice for prosumers of renewable sources from the Universal Service Supplier – KESCO,

in the session held on 29.01.2024 issued the following:

DECISION

- I. **APPROVAL** - of the **design of the electricity invoice** for the prosumers of renewable sources, which will be implemented in the entire territory of the Republic of Kosovo.
- II. The Universal Service Supplier KESCO is **OBLIGED** to implement the design of the electricity invoice for prosumers of renewable sources.

Reasoning

- ERO, on 12. 01.2024, received from the supplier KESCO the request on approval of the new design of the invoice for prosumers of renewable sources which will be implemented in the entire territory of the Republic of Kosovo.
- This request of KESCO derived from the legal requirements foreseen in Article 28, paragraph 5, of the Rule on General Conditions of Energy Supply as well as the Rule on Prosumers of Renewable Sources.
- KESCO, in their request emphasized that the new design was compiled in order to fulfil the criteria determined in Chapter III of the Rule on Prosumers of Renewable Sources.
- ERO Board reviewed the request of the supplier KESCO and evaluated that the new design of the invoice fulfils the requirements derived from Article 28 of the Rule on General Conditions of Energy Supply and Rule on Prosumers of Renewable Sources, respectively the new invoice shall contain all the information such as: the reduced energy component, unreduced network charge, unreduced tariff component and that will be presented in a clear and transparent manner.



- The decision is issued and published in official languages of the Republic of Kosovo.
- The decision shall enter into force on the date of approval by ERO Board and will be published in the official website of ERO.

Legal advice: The party dissatisfied with this decision may initiate an administrative dispute at the competent court within thirty (30) days from the date of receipt of the decision or the date of its publication on ERO's website, whichever occurs last.
